**ORDER OF FINAL JUDGMENT**

---

THIS MATTER came to be heard on the 2<sup>nd</sup> day of July 2004 before the Honorable D.J. Alissandratos. After statements from counsel; a careful review of the evidence and pleadings; and upon the entire record as a whole, the Court finds as follows:

1. That the Defendant willfully and knowingly violated the Tennessee Identity Theft Deterrence Act as well as the Tennessee Consumer Protection Act.
2. That the Defendant converted and wrongfully appropriated the Plaintiffs' funds and repeatedly committed acts of forgery as well as theft of property while using the Plaintiffs' name, identity, credit and/or likeness.
3. That the Defendant engaged in outrageous conduct against the Plaintiffs.
4. That the Defendant inflicted emotional distress on the Plaintiffs.
5. That the Plaintiffs have incurred substantial monetary losses and should be awarded \$50,000.00 in compensatory damages; punitive damages in the amount of \$1,000,000.00; and their reasonable attorney fees in the amount of \$4,500.00.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:**

1. That the Plaintiffs are collectively awarded a total judgment against the Defendant, Lashandra Moore a/k/a Lachandra Moore, of \$1,054,500.00.
2. That the Temporary Injunction previously issued in this matter be declared to be a Permanent Injunction, enjoining the Defendant, Lashandra Moore a/k/a Lachandra Moore, her agents, servants, employees and attorneys and all persons in active concert and participation with her from using, or in any way benefiting from, the Plaintiffs' name, identity, credit, money and/or property.
3. That all of the court costs are assessed against the Defendant, Lashandra Moore a/k/a Lachandra Moore, for which execution may issue.
