ORDER OF FINAL JUDGMENT

THIS MATTER came to be heard for trial on the 29th day of April 2003 before the Honorable Robert A. Lanier. After statements from counsel of the Plaintiffs and the Defendant; the testimony of the Plaintiffs and the Defendant; and upon the entire record as a whole, the Court finds as follows:

1. That the Defendant is guilty of intentional misrepresentations which caused the Plaintiffs to collectively incur losses of \$170,000.00.
2. That the Defendant willfully and knowingly converted said \$170,000.00 to his own personal use and benefit.
3. That the Plaintiffs should be collectively awarded \$170,000.00 in compensatory damages (\$101,200.00 to TOGA, LLC; \$61,500.00 to John Donati; and \$7,300.00 to Louis Mattei).
4. That the Plaintiffs should also be collectively awarded prejudgment interest in the amount of \$29,750.00 (\$17,710.00 to TOGA, LLC; \$10,762.50 to John Donati; and \$1,277.50 to Louis Mattei).
5. That the Plaintiffs should also be collectively awarded punitive damages in the amount of \$510,000.00 (\$303,600.00 to TOGA, LLC; \$184,500.00 to John Donati; and \$21,900.00 to Louis Mattei).

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

1. That the Plaintiffs are collectively awarded a total judgment against the Defendant, Benjamin Johnson d/b/a Interlink Communication Solutions, of \$709,750.00 (\$422,510.00 to TOGA, LLC; \$256,762.50 to John Donati; and \$30,477.50 to Louis Mattei).

2. That all of the court costs are assessed against the Defendant, Benjamin Johnson d/b/a Interlink Communication Solutions, for which execution may issue.




